- I understand that if I fail to comply with Urban Hens Pilot By-law I will, upon receiving notice from the Township, remove my hens from the Township of North Dumfries. The Owner understands that upon notice, the permission to keep hens in the Township may be revoked and the continued keeping of hens will be an offence under Part IV of the Urban Hens Pilot By-law.
- I understand that the Clerk's Office may establish additional standards and require all participants to comply with such standards during the pilot program to the satisfaction of the Clerk's Office. Any additional standards will be provided to all permit holders with a clear deadline under which the Owner must comply. The Owner understands that failure to comply with any additional standards established during the pilot project to the satisfaction of the Clerks Office will result in permission to keep hens in the Township to be revoked. If revoked, the continued keeping of hens will be an offence under Part IV of the Urban Hens Pilot By-law.
- I understand that any permit issued pursuant to the said application is subject to revocation at any time by the Township.

- I understand and acknowledged that the Urban Hens Pilot By-law expires on April 15, 2022 and the program for allowing backyard hens in the Township may change, or no longer be permitted. As such, I understand and acknowledge that if the Township no longer continues this program, that the Owner is responsible for removing all registered hens and hen coops from the Township of North Dumfries.
