



EFFECTIVE SEPTEMBER 22, 2021

In response to the REOPENING ONTARIO (A FLEXIBLE RESPONSE TO COVID-19) ACT, 2020, AMENDING O. REG. 364/20 Regulations and the Township of North Dumfries **COVID-19 Vaccination Policy**, The Township of North Dumfries has implemented the following protocol:

All person(s) entering the Township of North Dumfries facilities including:

- North Dumfries Community Complex,
- Ayr Community Centre,
- Roseville Community Centre

to participate in or watch any leisure or recreational activity or to attend a meeting or event, must show proof of a valid vaccination.

A person is exempt from the requirement under subsection (1) for anyone:

- (a) who are under 12 years of age;
- (b) who are under 18 years of age, and who are entering the indoor premises of a facility used for sports and recreational fitness activities solely for the purpose of actively participating in an organized sport, in accordance with guidance published by the Ministry of Health on its website for the purposes of this provision;
- (c) who provide a written document, completed and supplied by a physician or registered nurse in the extended class, that sets out, in accordance with the Ministry's guidance mentioned in subsection (4),
- (d) Anyone entering to use a washroom or to engage in Township Municipal Office business (i.e. pay taxes, permits etc).

Proof of Vaccination will include:

- One piece of ID. Acceptable forms of ID must include the name of the identification holder, and date of birth, these include:
 - o Birth certificate
 - o Citizenship card
 - o Driver's licence
 - o Government (Ontario or other) issued identification card, including health card
 - o Indian Status Card /Indigenous Membership Card
- Proof of Vaccination – at this time the government issued paper copy.

Steps for Businesses and Organizations: Proof of Vaccination

- 1 Match the **name** and the **date of birth** of the patron listed on the vaccination receipt against the name and date of birth on a piece of identification.
- 2 Verify the receipt is either:
 - an Ontario receipt (illustrated)
 - a receipt signed by an Indigenous health provider
 - a receipt from another jurisdiction
- 3 Verify that the receipt shows that the holder is fully vaccinated (see slide 9).
- 4 Verify that the **date of administration** of the final shot in the series is at least **14 days** prior to the date the patron is seeking access to the business or organization.

Sports Rental Groups:

All indoor sports rental groups will be responsible for proof of vaccination in addition to contact tracing and screening for their applicable members and recording and maintaining this information. The Township has hired a security firm that will check proof of vaccination weekday evenings and weekends. The Province has exempted coaches, trainers and officials from showing vaccination proof.

Walking Track Participants:

The walking track will be open daily from 8:30 a.m. to 9:00 p.m. (closed during Ayr Centennial games and during weekend hockey tournaments or special on-ice events) All walking track participants will show proof of vaccination to Township office staff or security personnel.

Fitness Class Participants:

All participants must show proof of vaccination to the fitness trainer. The fitness trainer must also show proof of vaccination to Township Staff.

Rental Room Users:

All individuals or groups renting space within Township facilities for meetings, events, performances, or programming, other than religious services, funeral or wedding ceremonies, must provide proof of vaccination to the Township and be responsible for proof of vaccination in addition to contact tracing for all attendees and/or participants of their event.

Drop in Programming (Pickleball):

All participants wishing to participate in pickleball must have proof of vaccination at time of registration.

Contractors:

All contractors hired by the Township must show proof of vaccination to the onsite staff that will accompany them in the building.

Please note that Township staff are only enforcing the Provincial Regulations.

In the event of harassment or threats of violence to Township staff, volunteers, user groups, or event organizers, law enforcement will be contacted, and facility use will be suspended.
